Advancement	<ul style="list-style-type: none">– Describe how studying a degree/subject at Kaplan Business School would enable you to advance your career in analytics– Elaborate briefly on which specific knowledge or skills would aid your career development	30%
Awareness	<ul style="list-style-type: none">– Reflect on the current state of diversity in the analytics industry, and why diversity is important– Speculate on how diversity will affect future advancements and developments in the field	20%
Advocacy	<ul style="list-style-type: none">– Evaluate the barriers women, and other groups, face in entering the analytics industry (internal perceptions as well as external factors)– Formulate a strategy you would employ to increase diversity in analytics from a position of power in the industry	30%
Presentation Style	<ul style="list-style-type: none">– Stay within the word limit– Address all points succinctly and clearly	20%

SELECTION PROCESS

- Kaplan Business School will review each application.
- On the recommendation of an Awards Committee, scholarships will be awarded to applicants who have demonstrated that they meet the selection criteria and that their video submission satisfies the requirements. The decision of the Awards Committee will be final.

- For single subject study, successful applicants will receive 30% off their first subject, and after this will need to enrol into a KBS degree to continue receiving the 30% discount.
- Students on the award can apply for Recognition of Prior Learning – RPL.
