People seeking asylum are confronted by many challenges that arise from the insecurity they have fled and the unpredictability that awaits them. One such challenge is the funding of a qualification that can strengthen their potential and expand their opportunities. To that effect, Kaplan Business School makes five scholarships available per year for any undergraduate or postgraduate course, one for each campus in Adelaide, Brisbane, Gold Coast, Melbourne, Perth and Sydney, equal to 100% of the tuition fees for the full duration of the course.

# SCHOLARSHIP FOR ASYLUM SEEKERS ELIGIBILITY CRITERIA

To be eligible for the **Scholarship for Asylum Seekers**, you must:

- Have met Kaplan Business School's academic requirements for the course offered.
- Have met Kaplan Business School's English language proficiency requirements for the course offered or will have met these requirements prior to commencing study with Kaplan Business School.
- 3. Hold a Temporary Protection Visa (subclass 785), a Safe Haven Enterprise Visa (subclass 790) or a Bridging Visa E (subclass 050 or 051). For more information about these visas visit immi.homeaffairs.gov.au.
- 4. Commence your studies in either 2025 or 2026.
- 5. Not be a recipient of any other Kaplan Business School scholarship, award or promotion.





### **IMPORTANT DATES**

Applications for the Scholarship for Asylum Seekers will need to be submitted by 30 September 2025.

You will be notified of the outcome of your application by 15 November 2025. Successful scholarship recipients will then be able to select in which of the subsequent three trimesters they prefer to commence:

TRIMESTER 1, 2026 MARCH
TRIMESTER 2, 2026 JULY

TRIMESTER 3, 2026 NOVEMBER

### SELECTION PROCESS

- Kaplan Business School will review each application.
- On the recommendation of a Selection Committee, scholarships will be awarded each trimester to a limited number of students who have demonstrated that they meet the selection criteria to the satisfaction of Kaplan Business School.
   The decision of the Kaplan Business School Committee will be final.

### **TERMS AND CONDITIONS**

- Applicants must not have commenced or completed any other higher education program at an Australian institution.
- Once enrolled, scholarship recipients must maintain an enrolment of at least one subject per trimester.
- Grades must be maintained at a Pass average.
- Once a campus-based scholarship has been awarded, it will be 12 months before it is next offered for that campus.
- Students can opt for an online enrolment instead.
- Quotas apply.
- Scholarships are only awarded to students who meet the Eligibility Criteria.
- Kaplan Business School reserves the right to offer scholarships at its sole discretion.
- Kaplan Business School reserves the right to withdraw any offer of a scholarship where the student has not yet accepted the offer or enrolled in the course by the date specified in the Letter of Offer. Scholarships are not available to students coming to Kaplan Business School via sponsoring bodies.
- Kaplan Business School reserves the right to amend the terms and conditions of the Scholarship for Asylum Seekers at any time.


