FAQs for Agents on Trimester 2 Accelerated (T2X)

Q: How may weeks does T2X will run for?

T2X runs for 6 weeks, plus 1 exam week for those subjects that have exams: ACCM4000 Financial Accounting and ACCM4100 Management Accounting.

Q: What is the minimum subject load for T2X?

Students can undertake a minimum 1 subject study load. Please note, as this is an accelerated course, 1 subject is equivalent of a full-time study load for most courses. However, students are allowed to undertake a maximum of 2 subjects.

Q: Will students have access to all courses in T2X?

KBS will be offering only Post Graduate (PG) courses in T2X. Please see a list of PG courses in this list.

Q: Will T2X be offered in all 5 campuses in Australia?

Yes. T2X is offered in all our campuses – Sydney, Melbourne, Brisbane, Adelaide and Perth However the Masters of Accounting and Masters of Professional Accounting are not offered in Perth in 2020).

Q: Will the students complete on time to commence Trimester 3 2020?

Yes. T2X ends on 6th November 2020. Students will then join the standard T3 intake, commencing on Monday 16th November.

Q: Can students apply for the standard Trimester 3 now instead of T2X?

Yes. T2X offers a fantastic option of studying 1 subject load. This will not be available in Trimester 3. Trimester 3 requires a minimum of a 2 subjects study load.

Q: Can current students of KBS undertake T2X?

T2X is only available to new students. Current students will follow the standard Trimesters.
